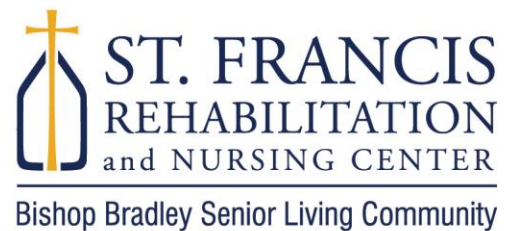

Dear Residents, Tenants, Family Members and Employees,

I am writing to you to give you an update on things that are happening at St. Francis. This morning we had employee who tested positive on a rapid test after she stated that she was not feeling well. The employee is vaccinated and always wears a mask and eye wear during working hours. We have been in contact with the NH Public Health Department and Catholic Charities. NH Public Health Department has stated that we need to do two rounds of Covid 19 PCR testing over the next two weeks for all residents, tenants and employees. We are planning to do the PCR tests this coming Sunday and Monday and will let you know the results of these tests as soon as we have them. We will not have community dining or activities during this time while we are testing for the next 14 days or so. Our family visitation needs to be done in a limited way over the next two weeks. We have been directed that compassionate care visits may continue but need to be done in a limited way. They cannot be done as a routine. Some examples of why they can be offered are; to help a resident when they are first admitted to help them adjust to their new environment, to be with a resident who is terminally ill and close to the end of life, to console a resident who shows signs of depression or anxiety. Please continue to call Diane at ext. 300 to schedule your visits and keep in mind the guidelines that we have. You may also reach us to schedule window visits or electronic visits. Brandy can help with this at ext. 313 or Alex at ext. 338. We will be wearing N95 masks and face shields. These test samples will be sent out to the NH Public Health lab. Based on test results they will give us further guidance on how to proceed. We will keep you updated with any changes that happen.

I wanted to thank you all for your participation in our most recent zoom family meeting call this past Wednesday. We will plan to continue this on a monthly basis and next month we will invite Alex Cave, our Life Enrichment Director to attend to discuss in more detail our activities program that we offer our residents.

I also wanted to let you know that we have rolled our new Mandatory Vaccine policy for all staff members this past week. We only have a small percentage of employees who do not have the vaccine. Effective September 13, 2021 all employees will be required to have at least their first dose of the vaccine and they will be required to be fully vaccinated by October 25, 2021

I have had several ask me questions about the vaccine booster. At this time, I do not have much information to relay about the booster but I am sure I will in the coming weeks and I will keep you informed as I learn more about it and when we might offer it to our residents and employees.

The positivity rate of Covid 19 is going up in our county. Belknap County is considered in substantial transmission. I would like to encourage you all to wear masks when you are in a public setting. This applies even to vaccinated people due to the different variants that are being discovered.

While we know this is an incredibly challenging time for you and your family, please be assured that we remain committed to the care and support of your loved one here at St. Francis. Their safety, health and well-being remain our firm commitment.

We will continue to keep you updated as time goes on.
